OSHPD PRE-APPROVAL (OPA) NUMBERS

The Office of Statewide Health Planning and Development (OSHPD) Pre-Approval (OPA) numbers are now available for Great Lakes most popular racks, enclosures, and wall mounts. Products were independently reviewed and submitted to OSHPD and are now certified to be in compliance with the seismic anchorage requirement outlined in Section 1708A.1.3 and Section 1708.4.2 of the 2010 California Building Code.

OSHPD created its pre-approval program as a voluntary process which would allow manufacturers to submit their products for independent review and approval prior to use in health facility construction projects, eliminating the time and money required for review of those products during the project's OSHPD construction plan review.
